THE HERTFORDSHIRE (TEMPORARY CLOSING OF VARIOUS ROADS IN BARKWAY DURING THE 'REMEMBRANCE SUNDAY PARADE') ORDER 2023

The Hertfordshire County Council, in exercise of their powers under Section 16A of the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order may be cited as "The Hertfordshire (Temporary Closing of Various Roads in Barkway during the 'Remembrance Sunday Parade') Order 2023" and shall come into operation between the hours of 10.45am and 11.45m on Sunday 12 November 2023, when signs are in place.
2. Nothing in this Order shall apply to Fire and Rescue, Police and Ambulance Service vehicles during the course of an emergency.
3. All vehicular traffic is prohibited from using that length of B1368 Cambridge Road, Barkway from its junction with Royston Road north eastwards to its southernmost junction with Bonds Crescent, a distance of approximately 105 metres.

An alternative route will be via B1368 (Cambridge Road/London Road/Biggin Hill/unnamed road), B1038 (unnamed road/Hare Street Road/High Street/Baldock Road), A10 (Buntingford Bypass/unnamed road/Ermine Street/London Road/Market Hill/Priory Lane), B1039 (Barkway Road/Royston Road) and B1368 (High Street/London Road/ Cambridge Road)

or via B1368 (Cambridge Road/London Road/High Street), B1039 (Royston Road/Barkway Road), A10 (Barkway Street/London Road/Ermine Street/unnamed road/ Buntingford Bypass), B1038 (Baldock Road/High Street/Hare Street Road/unnamed road) and B1368 (unnamed road/Biggin Hill/London Road/Cambridge Road).

4. All vehicular traffic is prohibited from using that length of B1368 High Street, Barkway from its junction with Church Lane north eastwards to its junction with Royston Road, a distance of approximately 304 metres.

An alternative route will be via B1368 (Cambridge Road/London Road/Biggin Hill/unnamed road), B1038 (unnamed road/Hare Street Road/High Street/Baldock Road), A10 (Buntingford Bypass/unnamed road/Ermine Street/London Road/Market Hill/Priory Lane), B1039 (Barkway Road/Royston Road) and B1368 (High Street/London Road/Cambridge Road)

or via B1368 (Cambridge Road/London Road/High Street), B1039 (Royston Road/Barkway Road), A10 (Barkway Street/London Road/Ermine Street/unnamed road/ Buntingford Bypass), B1038 (Baldock Road/High Street/Hare Street Road/unnamed road) and B1368 (unnamed road/Biggin Hill/London Road/Cambridge Road).

5. All vehicular traffic is prohibited from using that length of Royston Road, Barkway from its junction with B1368 High Street north westwards to its junction with Windmill Close, a distance of approximately 224 metres.

An alternative route will be via B1368 (Cambridge Road/London Road/Biggin Hill/unnamed road), B1038 (unnamed road/Hare Street Road/High Street/Baldock Road), A10 (Buntingford Bypass/unnamed road/Ermine Street/London Road), The Joint and Royston Road

or via B1368 (Cambridge Road/London Road/High Street), B1039 (Royston Road/Barkway Road), A10 (Barkway Street/London Road), The Joint and Royston Road.

6. In making this Order, the Hertfordshire County Council is satisfied that all vehicular traffic should be prohibited from using the above lengths of roads to ensure public safety and prevent accidents whilst the 'Remembrance Sunday Parade' takes place.
